

TERMS OF USE - Agritempo

1. General

This term provides the rules for using the web system Agritempo which is available at: http://www.agritempo.gov.br

The Agritempo system is owned and operated by Embrapa Agricultural Informatics and the Center of Meteorological and Climatic Research Applied to Agriculture (Cepagri), of the State University of Campinas (Unicamp).

For the purposes of these terms, any natural or legal person who freely access this system via the Internet, is called a User.

2. Purposes of Agritempo System

The Agrometeorological Monitoring System (Agritempo) provides data and daily weather forecast and climate information for Brazilian territory. The system eceives data coming from more than 1,400 weather stations across Brazil, some belonging to the partner institutions.

Agritempo offers regional agrometeorological bulletins, meteorological products presented as maps, weather forecasts for the capital of each state, information related to the Agricultural Zoning Climate Risk and historical series of weather data, among other products.

3. Rights and Responsibilities

- 3.1 Embrapa Information and Cepagri / Unicamp:
 - Are holders of intellectual property rights relating to the content published on Agritempo web system (in the form of raw data, text, photographs, sounds, videos, maps, images and graphics), as well as its software and associated brands, as established the Copyright Law No. 9610 of 19/02/1998 of the Brazilian Federal Government and related.
 - Are holders of the intellectual property rights of the raw data they provide to the system.
 - Present the data and the meteorological information in Agritempo system strictly according to scientific standards of the field.
 - Are not responsible for any interruptions or failures of access to Agritempo system due
 to technical problems as well as any third-party content cited and hosted on Agritempo
 system, particularly in news sections and in publications disseminated on the website.

The owners have the right, at any time, to change or discontinue any the System or any aspect or feature of the System, including, without limitation, the content and hours of availability, without notice (except as and when required by law or as stated in these Terms of Use).

The owners disclaim to any liability, judicial or extrajudicial, on any damage, loss and / or damage arising from the use of meteorological data and information Agritempo system.



3.2 User

The User is responsible for providing the technological resources necessary to access the system Agritempo, being aware that the presentation of the content can vary, depending on which web browser to access the system, or the chosen configuration.

The User is fully responsible for the data and information to be inserted in Agritempo system as well as for the correct use of the system, being the sole responsible for possible inaccuracies in reported data, exempting the owners from any liability for acts arising from their actions.

The User agrees not to infringe any third party rights, such as intellectual property rights of stakeholders and partner institutions of the system, among other rights.

It has guaranteed the confidentiality of the User's navigation data.

4. Restrictions on Use

Reproduction, storage, transmission, copying, distribution or any other form of commercial use of hosted content are prohibited, except as written expressly permitted by Embrapa and Cepagri / Unicamp.

Republication and distribution of public content are permitted provided since the source, title and author are referenced. The use of restricted content (raw data) is not permitted without authorization of the owners

5. Applicable legislation

These Terms of Use is governed by the laws pertaining to the matter, particularly the Industrial Property Law. 9,279, of 05.14.1996, and the Copyright Law. 9610 of 19/02/1998, on national territory, and the Agreement on Aspects of Intellectual Property Rights Related to Trade (TRIPS) internationally.
